The County Auditor received 1 letter in favor of the wind turbine cap and received no additional comments. Supervisor Hoadley received one written comment from Ron Lauer and Sherri Kramer who are against putting a cap on the wind turbines. The following people spoke in favor of the wind turbine cap: Curt Beane, Joanie Finck, Colleen Oxley, Tammy Baier, Bertha Matthis, Tanya Lamb, Paul Ehm, Rachel Terhaar, Greg Beaman, Lorrie Beaman, and Jane Cooper. Supervisor Hoadley spoke to the frustrations of those affected by the wind turbines and her personal experiences with the wind turbines. Shelley stated that he has a contract with Mid-American and declare his son, daughter-in-law and wife also have a contract and will abstain from the discussion. Moved by Twombly and seconded by Homan to close the public hearing at 10:26 a.m. Shelley, abstained. Approved.

CONSIDERATION OF THE 2ND AND 3RD READING OF ORDINANCE NO. 31B: Moved by Twombly and seconded by Hoadley to waive the 2nd and 3rd reading of Ordinance 31B. Roll Call Vote: Wedemeyer, aye; Twombly, aye; Homan, aye; Hoadley, aye; Shelley, abstain. Approved.

RESOLUTION APPROVING ORDINANCE NO. 31B: Moved by Twombly and seconded by Homan to approve **Resolution #2019-44** – Approval Of Ordinance No. 31B An Amendment To Ordinance No. 31 – Assessment Of Wind Energy Conversion Property WHEREAS, the Board of Supervisors of the County of Adair, State of Iowa, after public notice and hearing as prescribed by law; and WHEREAS, the purpose of the ordinance is to amend Ordinance No. 31 – Assessment of Wind Energy Conversion Property by adding an additional section and to exercise the County's police powers under the County Home Rule Implementation Act Iowa Code Chapter 331 and 335.3; THEREFORE, the Board hereby adopts Ordinance 31B, with the ordinance to be effective 0 days after final publication of said ordinance. Roll Call Vote: Wedemeyer, aye; Twombly, aye; Hoadley, aye; Homan, aye; and Shelley, abstain. Approved.

AUDITOR: FY19 Annual Urban Renewal Report - Auditor Berg presented the FY19 Annual Urban Renewal Report. Moved by Twombly and seconded by Hoadley to approve the FY19 Annual Urban Renewal Report and for the Auditor to file it with the State. Approved, FY19 Cash Financial Report - Auditor Berg presented the FY19 Cash Annual Report. Total Revenues increased 1.4% from FY18. The following resulted in the overall increase: property taxes levied increased \$182,000, LOST revenue increased \$152,000, and TIF revenue increased \$104,000. The expenditures increased \$3.1 million dollars from FY18. Approximately \$1.5 million dollars of this increase was due to paying down the Public Safety Center Bond at call. There were increases in the following expenditures: Public Safety and Legal by \$155,000, Health and Social Services by \$40,000, Mental Health by \$19,000, Roads and Transportation by \$357,000, Administration by \$61,000, Long Term Debt of \$1.88 million and Capital Projects by \$869,000. County environment and Government Services decreased by \$8,000 and \$6,000 respectively. FY19 ended with the following fund balances: General – 35%, General Supplemental – 24%, Rural Services 52%, and Secondary Roads – 32%. Moved by Shelley and seconded by Hoadley to approve and publish the FY19 Cash Annual Report. Approved. ISAC Wellness Program – Auditor Berg presented the results of the FY19 Wellness Program. The percentage of County Employees needed to receive the 5% discount on the County's Health Insurance Premiums for FY21 was met. IMWCA Site Visit - Auditor Berg informed the Board that IMWCA made a site visit on October 29, 20199 and took a tour of the Secondary Roads Shop. Auditor Berg went over the recommendations that were made by IMWCA to improve safety at the workplace. The Board would like to table the responses to the recommendations until we are to complete some of them. Actuarial Services Agreement - Auditor Berg informed the Board that GASB 45 requires a full actuarial valuation done on the County's benefit plans every three years. SilverStone Group, Inc. has done this actuarial in the past the cost has went up slightly to not exceed \$3,350. Moved by Twombly and seconded by Shelley to sign the actuarial services agreement with SilverStone Group, Inc. Approved.
