CHILD ABUSE PREVENTION GRANT DRAW DOWN: Moved by Twombly and seconded by Hoadley to approve Auditor Berg, as contract administrator, to sign the Child Abuse Prevention Grant Draw Down. Approved.

COURTHOUSE SAFETY MEETING RECAP: Supervisor Shelley gave a recap on the Courthouse Safety Meeting held on Monday with Judge Reynolds and other County department heads. During the meeting it was discussed when we would like to open up the Courthouse for services and what needed to be done in order to do that. It was said that we would be deciding at the department head meeting on June 9th when we would like to open the Courthouse and what precautionary measures we would like in place. Shelley stated that Judge Reynolds had also held meetings with Union County and Clarke County that morning. Union was opening partially and Clarke County wasn't as interested in opening at this time. County Attorney Larson mentioned during the meeting that she believes that the magistrate is currently handling things well with the court system. Shelley stated that there was no pressure from Judge Reynolds to open the courthouse, but was just inquisitive on what help we needed in making these decisions. Brenda Wallace, County Treasurer entered at 2:41 a.m.

The Board would like Engineer Kauffman to present his recommendations for his department and the impact they would have on his budget and discuss the remaining changes to policies at the department head meeting on June 9th. Smisek exited the phone call at 3:44 p.m.
