COMPENSATION BOARD APPOINTMENT: Treasurer Wallace submitted a letter to the Board stating that her compensation board member, Cindy Hennigar submitted her resignation and Wallace has appointed Todd Lamb to complete the rest of the term. Moved by Twombly and seconded by Hoadley to acknowledge the Treasurer's appointment of Todd Lamb to the compensation board until the term expires on June 30, 2021. Approved.

GRANT DRAW DOWN: Moved by Shelley and seconded by Homan for Auditor Berg, as contract administrator, to sign the child abuse prevention grant draw down. Approved.

COVID-19 UPDATES & DISCUSSION: The Board discussed the increase in cases and deaths in Adair County. Supervisor Twombly would like to keep things the same with how the Courthouse has been operating. Supervisor Hoadley agreed stating that we need to keep the best interest of the employees and families in mind. Supervisor Shelley added that he thinks we need to lean towards whatever option is the safest for employees which may mean that offices may need to go back to rotating schedules or working from home. Shelley believes that department heads know what is best for their employees and can make those decisions.

NW WIND FARM AMENDMENT #2 URBAN RENEWAL PLAN: Public Hearing - Moved by Homan and seconded by Shelley to open the public hearing at 9:10 a.m. Approved. Auditor Berg presented the Board with the Consultation Report that was prepared as a result of the Consultation Meeting that was held on November 5, 2020 for the affected taxing entities. Supervisor Twombly stated that Auditor Berg received a phone call from the Adair City Attorney regarding the City's main road being added to the Urban Renewal Plan. Twombly stated that this was not something he believes should be added. Supervisor Hoadley stated she received a phone call regarding Orient and making sure that the City could only use the revenue from the turbines within their two-mile radius. Auditor Berg stated that she had one resident call and asked for a copy of the Urban Renewal Plan and one resident who had seen the notice in the paper and was concerned about more turbines being put up. No other written or verbal comments were received from the public nor received by the Supervisors or Auditor's office. Vinton Ave. from 330th St. to Adair-Union Ave.

WHEREAS, this Area is within two miles of the cities of Greenfield, Stuart, and Orient, and the County has entered into a joint agreement with the cities to allow the County to operate within the Area; and WHEREAS, it is desirable that the Area be redeveloped as part of the activities described within the proposed Amendment No. 2; and WHEREAS, by resolution adopted on October 28, 2020, this Board directed that a consultation be held with the designated representatives of all affected taxing entities to discuss the proposed Amendment No. 2 and the division of revenue described therein, and that notice of the consultation and a copy of the proposed Amendment No. 2 be sent to all affected taxing entities; and WHEREAS, pursuant to such notice, the consultation was duly held as ordered by the Board of Supervisors and all required responses to the recommendations made by the affected taxing entities, if any, have been timely made as set forth in the report of the County Auditor, or her delegate, filed herewith and incorporated herein by this reference, which report is in all respects approved; and WHEREAS, by resolution this Board also set a public hearing on the adoption of the proposed Amendment No. 2 for this meeting of the Board, and due and proper notice of the public hearing was given, as provided by law, by timely publication in the Adair News & Adair County Free Press, which notice set forth the time and place for this hearing and the nature and purpose thereof; and WHEREAS, in accordance with the notice, all persons or organizations desiring to be heard on the proposed Amendment No. 2, both for and against, have been given an opportunity to be heard with respect thereto and due consideration has been given to all comments and views expressed to this Board in connection therewith and the public hearing has been closed. NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF SUPERVISORS OF ADAIR COUNTY, STATE OF IOWA: That the findings and conclusions set forth or contained in Amendment No. 2 concerning the area of Adair County, State of Iowa, described in the preamble hereof, be and the same are hereby ratified and confirmed in all respects as the findings of this Board for this area. This Board further finds: Although relocation is not expected, a feasible method exists for the relocation of any families who will be displaced from the Urban Renewal Area into decent, safe and sanitary dwelling accommodations within their means and without undue hardship to such families; The Plan, as amended, and Amendment No. 2 conform to the general plan for the development of the County as a whole: and Acquisition by the County is not immediately expected, however, as to any areas of open land to be acquired by the County included within the Urban Renewal Area: Residential use is not expected, however, with reference to any portions thereof which are to be developed for residential uses, this Board of Supervisors hereby determines that a shortage of housing of sound standards and design with decency, safety and sanitation exists within the County; that the acquisition of the area for residential uses is an integral part of and essential to the program of the municipality; and that one or more of the following conditions exist: That the need for housing accommodations has been or will be increased as a result of the clearance of slums in other areas, including other portions of the urban renewal area. That conditions of blight in the municipality and the shortage of decent, safe and sanitary housing cause or contribute to an increase in and spread of disease and crime, so as to constitute a menace to the public health, safety, morals, or welfare. That the provision of public improvements related to housing and residential development will encourage housing and residential development which is necessary to encourage the retention or relocation of industrial and commercial enterprises in this state and its municipalities. The acquisition of the area is necessary to provide for the construction of housing for low and moderate income families. Non-residential use is expected and with reference to those portions thereof which are to be developed for nonresidential uses, such non-residential uses are necessary and appropriate to facilitate the proper growth and development of the County in accordance with sound planning standards and local community objectives. That the Urban Renewal Area, as amended, continues to be an economic development area within the meaning of Chapter 403, Code of lowa; that such area is eligible for designation as an urban renewal area and otherwise meets all requisites under the provisions of Chapter 403, Code of lowa; and that the rehabilitation, conservation, redevelopment, development, or a combination thereof, of such area is necessary in the interest of the public health, safety or welfare of the residents of this County. That Amendment No. 2 to the Adair County Northwest Wind Farm Urban Renewal Plan of Adair County, State of Iowa, attached hereto as Exhibit 1 and incorporated herein by reference, be and the same is hereby approved and adopted as "Amendment No. 2 to the Adair County Northwest Wind Farm Urban Renewal Plan for Adair County, State of lowa"; Amendment No. 2, including all of the exhibits attached thereto, is hereby in all respects approved; the Chairperson and County Auditor are authorized to execute the Joint Agreement; and the County Auditor is hereby directed to file a certified copy of Amendment No. 2 with the proceedings of this meeting. That, notwithstanding any resolution, ordinance, plan, amendment or any other document, Amendment No. 2 shall be in full force and effect from the date of this Resolution until the Board amends or repeals the Plan. The proposed Amendment No. 2 shall be forthwith certified by the County Auditor, along with a copy of this Resolution, to the Recorder for Adair County, lowa, to be filed and recorded in the manner provided by law. That all other provisions of the Plan not affected or otherwise revised by the terms of Amendment No. 2, as well as all resolutions previously adopted by this Board of Supervisors related to the Plan be and the same are hereby ratified, confirmed and approved in all respects. Supervisor Twombly performed the first reading of Ordinance 34B - An Ordinance Amending Ordinance Nos. 34 And 34a, Providing That General Property Taxes Levied And Collected Each Year On All Property Located Within The Amended Northwest Wind Farm Urban Renewal Area, In Adair County, State Of Iowa, By And For The Benefit Of The State Of Iowa, Adair County,

Adair-Casey Community School District, Nodaway Valley Community School District, Orient-Macksburg Community School District, And West Central Valley Community School District, And Other Taxing Districts, Be Paid To A Special Fund For Payment Of Principal And Interest On Loans, Monies Advanced To And Indebtedness, Including Bonds Issued Or To Be Issued, Incurred By The County In Connection With The Amended Northwest Wind Farm Urban Renewal Area (Amendment No. 2 To The Adair County Northwest Wind Farm Urban Renewal Plan) WHEREAS, The Board Of Supervisors Of Adair County, State Of Iowa, Has Heretofore, In Ordinance Nos. 34 And 34A, Provided For The Division Of Taxes Within The Northwest Wind Farm Urban Renewal Area ("Area" Or "Urban Renewal Area"), Pursuant To Section 403.19, Code Of Iowa; And WHEREAS, Additional Territory Now Has Been Added To The Northwest Wind Farm Urban Renewal Area Through The Adoption Of Amendment No. 2 To The Adair County Northwest Wind Farm Urban Renewal Plan; And WHEREAS, Indebtedness Has Been Incurred By The County, And Additional Indebtedness Is Anticipated To Be Incurred In The Future. Roll Call Vote: Twombly, aye; Hoadley, aye; Homan, aye; Shelley, aye; and Wedemeyer, aye. Approved.

AUDITOR: FY20 GAAP Annual Financial Report – Auditor Berg presented the FY20 GAAP Financial Report. Moved by Shelley and seconded by Wedemeyer to allow Auditor Berg to file the FY20 GAAP financial report with the state. Approved. Wellmark Authorization & Release Form – Moved by Hoadley and seconded by Shelley for the chair to sign the agreement authorizing Wellmark to release information to Auxiant as the County third party administrator. Approved. Tax Increment Financing (TIF) Debt Resolution: Moved by Homan and seconded by Shelley to approve Resolution #2020-52 – A Resolution Authorizing An Internal Advance To The Capital Projects Fund. Whereas, the County of Adair, Iowa (the "County"), has established the NW Wind Farm Urban Renewal Area and Amendment #1 (the "Urban Renewal Areas") and has established the NW Wind Farm Urban Renewal Area Tax Increment Revenue Fund (the "Tax Increment Fund") in connection therewith; and Whereas, the County has undertaken various urban renewal projects (the "Projects") within the Urban Renewal Areas and the immediate costs for said Projects are as follows:

- 1. Midwest Partnership for Economic Development services. Invoices total as follows for the period November 2019 through November 2020:
 - General Fund \$33,354.00
- 2. GO Bond, Series 2020 cost. Invoices total as follows for the period November 2019 through November 2020:
 - General Fund \$46,735.74
- 3. Set up of Urban Renewal Amendment #2 cost. Invoices total as follows for the period November 2019 through November 2020:
 - General Fund \$4,572.76

WHEREAS, in order to make the costs of the Projects eligible to be paid from future incremental property tax revenues, it is necessary to facilitate internal advances of funds; NOW, THEREFORE, IT IS RESOLVED by the Board of Supervisors of the County of Adair, Iowa, as follows: SECTION 1. It is hereby directed that an amount not to exceed Eighty-Four Thousand Six Hundred Sixty-Two Dollars and 50/100 Dollars (\$84,662.50) be advanced to the Capital Projects Fund from the County's General Fund (the "General Fund Advance") in order to pay the costs of the Projects. The General Fund Advance (the "Advance") will be repaid to the General Fund, out of future incremental property tax revenues received into the Tax Increment Fund. SECTION 2. A copy of this Resolution shall be filed with the office of the County Auditor of Adair County, Iowa to evidence the Advances. Pursuant to Section 403.19 of the Code of Iowa, the County Auditor is hereby directed to certify, no later than December 1, 2020, the original, aggregate amount of the Advances as provided for herein. SECTION 3. All resolutions or parts thereof in conflict herewith, are hereby repealed, to the extent of such conflict. Roll call vote: Twombly, aye; Shelley, aye; Hoadley, aye; Homan, aye; and Wedemeyer, aye. Approved. TIF Indebtedness Certification – Moved by Shelley and seconded by Hoadley for the Chair to sign the TIF Certification including the Certification of Indebtedness showing new indebtedness of \$5,180,667 and Certification of Specific Dollar Request of \$3,063,771. Approved.

EMERGENCY MANAGEMENT FY22 BUDGET: Bob Kempf, Emergency Management Coordinator joined the call at 9:32 a.m. Supervisor Twombly stated he had some questions concerning the emergency management's preliminary budget and the emergency management's reserve fund. Twombly asked if the reserve funds were used up, would the County be looking at a dramatic increase in the next couple years. Kempf stated that they always reserve 35% of their budget for things that they do no receive grants for or for unexpected expenses and that this should never become a problem. Kempf would like to take his part-time person who has been working over 30 hours consistently to full-time. There is plenty of work that needs to be done for two people. Supervisor Twombly stated from FY21 to FY22 that emergency management's proposed budget will be increasing by more than 13% which he believes is too much. Supervisor Hoadley stated that she was in agreeance and wanted other board members' opinions before the emergency management commission meets regarding the budget. Supervisor Shelley was wondering why the increase was so high when other expenses are remaining the same and if in the past the entire budget had been used. The Board discussed that the County only receives one vote on the emergency management commission and really has no control over the amount that is approved although it takes the heat for it and it affects the County's overall budget. Supervisor Wedemeyer stated that a couple years ago it took a lot of rearranging of the budget for the emergency management levy in order for the County to keep the County levies the same and doesn't feel it is necessarily fair for Cities to vote on the EMA budget when they don't have to levy anything. Kempf agreed but stated that it still affects their citizens, the money is just routed differently through the County. The Board discussed if it was possible to have their own emergency management but stated that the cost would most likely be

higher. Kempf stated that although he would like to have a second full time person, he doesn't know what the commission will pass. Another used vehicle has also been discussed but not budgeted for and could be bought from the reserve account which currently has a balance around \$55,000. Supervisor Twombly stated that he was not in favor of increasing the budget by more than 13%. Supervisor Hoadley stated that she believes she knows what the opinion of the Board is and will pass on this information to the emergency management commission.
