**CHILD ABUSE PREVENTION GRANT:** Moved by Shelley and seconded by Twombly for Auditor Berg, as contract administrator, to sign the Child Abuse Prevention Grant Draw Down. Approved.

**CONNECTIONS AGENCY ON AGING SURVEY:** Supervisor Twombly shared his answers to the survey. Moved by Wedemeyer and seconded by Hoadley to submit Supervisor Twombly's answers for the Connections Agency on Aging Survey. Approved.

**COVID-19 UPDATES AND DISCUSSION:** The Board would like to continue with how operations are going in the County. Auditor Berg had stated that the COVID-19 mandated sick leave from the Families First Response Coronavirus Act would be expiring on December 31, 2020 and wondered if the Board would like to extend that. The advanced sick leave the Board put into place at the beginning of the pandemic will remain in effect until the Board revokes or the public health emergency has ended.

SHERIFF: Jail Administrator New Hire – Sheriff Vandewater would like the Board to approve the hire of Michael Herbert as jail administrator and part-time deputy sheriff pending his pre-employment drug screening. Herbert would not be a regular salaried deputy as addressed in Chapter 341A of the Code (Civil Service) and as a civil process server as permitted in 331.652. Sheriff Vandewater would like Herbert to start with 10 days of vacation upon hire with a salary of \$45,000. The Board discussed whether the jail administrator should receive the yearly raise for FY22 and the vacation. Supervisor Wedemeyer stated there wasn't anything in the handbook stating that he would not receive the salary increase and thinks you that if you hire someone who has experience, they should be able receive better vacation. The Board would like Sheriff Vandewater to discuss these issues with HR Attorney Mike Galloway and come back on Monday to discuss. Moved by Shelley and seconded by Shelley to table the discussion until Monday. Approved. Engineer Nick Kauffman entered at 9:16 a.m.

**AUDITOR: OCIO MOU – Cybersecurity Services –** Auditor Berg presented a memorandum of understanding for the services provided by the OCIO for cybersecurity services. Adair County uses several services provided by the OCIO at no cost to the County. This MOU outlines what services can be provided to the County and includes services that are currently paid by the Federal Homeland Security Grant. Moved by Homan and seconded by Shelley for the chair to sign the Cybersecurity OCIO memorandum of understanding. Approved. **FY22 Insurance Renewal –** The Board had not made a final decision on insurance plans yet and would like to table until next week.

**ENGINEER:** Sign ROW Contract – Moved by Homan and seconded by Hoadley to approve the ROW Contract with Rolling Hills Farm Corp for .29 acres of right of way and .45 temporary easement for a total of \$2,970.94. Approved. **Report of Maintenance & Activities** – Kauffman gave an update on the following projects: snow removal, bridge contractors have shut down for the week, submitted budget to auditor and will meet with the board next week, would like to update the building North of the elevator with the remainder of the FY21 buildings budget, and had one electrical issue with a truck moving snow and was able to use the extra truck.

The Board thanked Supervisor Homan for his service to the County and wished him well in his retirement.
