TRAVEL POLICY RESOLUTION: Moved by Wedemeyer and seconded by Twombly to approve **Resolution #2021-03** – Adair County Travel Policy. Reimbursement for travel will be according to the Adair County Personnel policy or applicable union contract with the following limitations: Daily single lodging rate reimbursement or payment shall not exceed the lowest negotiated ISAC or ISAC affiliate price per day plus tax and for Non-ISAC meetings shall not exceed the lowest government price offered. An original receipt or bill must be presented for payment. Meal reimbursements if applicable will not exceed the following amount with original itemized receipt required: \$40.00/day. The County will not reimburse for tip or alcohol. Exceptions shall be made for meals included as part of school of instruction registration fee. The 2021 mileage reimbursement rate will be set at \$0.10 less than the IRS Rate for county employees on county business. The Sheriff will use the IRS Standard Mileage rate for functions billed for service within the office of the sheriff. SHERIFF: Jail Administrator New Hire – Sheriff Jeff Vandewater joined via conference call at 9:38 a.m. Sheriff Vandewater stated he had talked to Mike Galloway concerning the vacation and the yearly salary increase on a new hire and Galloway didn't have a problem with either. Sheriff Vandewater stated that after talking to Auditor Berg about the handbook language and the vacation schedule of a new hire, he had asked Galloway if this was a common issue. Galloway replied that this has happened frequently and suggested the language to be changed in the handbook. The Board discussed that the Jail Administrator would receive the hourly wage increase and would not receive the increase the Sheriff receives at the new fiscal year. Moved by Twombly and seconded by Hoadley to accept Sheriff Vandewater's request to hire Michael Herbert as jail administrator and part-time deputy sheriff pending his pre-employment drug screening. Approved. Herbert will not be a regular salaried deputy as addressed in Chapter 341A of the Code (Civil Service) and as a civil process server as permitted in 331.652 and will start with 10 days of vacation upon hire with a salary of \$45,000.
