Due to heightened public health risk from the coronavirus outbreak, the Board Meeting was held via conference call pursuant to lowa Code section 21.8 along with in-person public attendance in the boardroom.

MINUTES: Moved by Wedemeyer and seconded by Twombly to approve the minutes from August 4, 2021. Approved.

LIQUOR LICENSE RENEWAL: Moved by Hoadley and seconded by Walker to approve the liquor license renewal for Carol Ann Root. Approved.

MANURE MANAGEMENT PLAN UPDATE: Moved by Twombly and seconded by Shelley to acknowledge receipt of the manure management plan update from Westlake Swine. Approved.

HOMESTEAD & MILITARY DISALLOWANCES: Moved by Wedemeyer and seconded by Hoadley to approve the 17 Homestead and 4 Military Disallowance and for the chair to sign the disallowance letters. Approved.

COVID-19 UPDATES & DISCUSSION: The County has only had one positive COVID-19 case within the last 7 days. Auditor Berg presented a letter from Susie Olesen regarding expanding the COVID relief funding to other organizations and businesses within the County. Supervisor Wedemeyer stated that he would like to see what the County's needs are first, but would also like to set aside a portion of this money to use as a grant process for businesses that may be in need. COUNTY IT DISCUSSION: Neil Hyde – Infomax, Duane Avey – VA Director, and Nick Kauffman – County Engineer entered at 9:20 a.m. Dan King, Avatara, joined via conference phone at 9:20 a.m. Janelle Schneider, Recorder entered at 9:24 a.m. Hyde gave an overview on the migration of the County's IT and the challenges that Infomax and Avatara experienced during migration. Hyde explained that there were still some outstanding items with the Engineer's office that needed to be dealt with that they were unaware of and that King has been in contact with them on these issues and will be meeting with their office on Friday to get them resolved. Hyde believes that the employees have had some hesitancy to open tickets and put in orders to resolve issues as they fear it will increase the county's cost. He explained that the only time the billing changes is when the County is adding or deleting users. Supervisor Wedemeyer stated that he realizes this has been a big change and they are wanting to make sure all of the County's needs are being met. Supervisor Hoadley stated that she would like to recommend Infomax/Avatara to other people, but she needs to know we are being taken care of in order to make that recommendation. Supervisor Shelley stated that he believes communication needs to be improved in order to get problems solved. Hyde stated that at no point will they drop us and they will make a point to set up quarterly meetings with department heads to go over performance, resolve any issues, and to discuss any upcoming projects.
