WELLNESS PROGRAM UPDATE: Supervisor Walker stated that the Wellness Committee had received the County's final wellness numbers for 2021 and the County will be receiving the maximum 5% premium discount for FY23 insurance premiums. Supervisor Shelley asked Auditor Berg to send out a thank you to employees who participated and encourage them to continue to participate.

IMWCA SITE VISIT: Auditor Berg informed the Board that IMWCA completed their annual safety site visit on October 5, 2021. IMWCA reported that the site visit revealed that our facilities were in good order and either there were no safety issues identified or the concerns are in the process of being properly addressed. Moved by Twombly and seconded by Walker to acknowledge receipt of the site visit letter from IMWCA. Approved.

JAIL INSPECTION: The Board received a letter from the jail inspection performed for the County on October 25, 2021. One recommendation was received from the jail inspector stating that all jail checks need to be completed at least once an hour as there were multiple occasions that were in excess of one hour as required by the IAC. Moved by Walker and seconded by Twombly to acknowledged receipt of the jail inspection letter. Approved.

COVID-19 UPDATES & DISCUSSION: Supervisor Shelley stated that he had family members who had tested positive. There has been no update on the S.3011 bill.
