Moved by Walker and seconded by Hoadley to approve **Resolution #2022-20** – Approval of FY23 Maximum Property Tax Dollars Whereas, the Adair County Board of Supervisors have considered the proposed FY23 county maximum property tax dollars for both General County Services and Rural County Services, and Whereas, a notice concerning the proposed county maximum property tax dollars was published as required and posted on county web site and/or social media accounts if applicable, Whereas, a public hearing concerning the proposed county maximum property tax dollars was held on February 23, 2022, Now Therefore Be It Resolved by the Board of Supervisors of Adair County that the maximum property tax dollars for General County Services and Rural County Services for FY23 shall not exceed the following: General County Services: \$3,417,385; Rural County Services: \$2,061,915 The FY22 Maximum Property Tax dollars requested in the General County Services increased by 11.04% whereas the Rural County Services increased by 11.46% from the Maximum Property Tax dollars requested for FY22. Roll Call Vote: Wedemeyer, aye; Twombly, aye; Shelley, aye; Hoadley, aye; and Walker, aye. Approved. **Set Public Hearing –** Moved by Shelley and seconded by Twombly to set the public hearing for the FY23 Budget for March 16, 2022 at 9:15 a.m. Approved.
