AUDITOR: County Website Proposals – Auditor Berg distributed four different proposals to update the County website from Revise Government Websites and Schneider Geospatial. Berg stated that there are updates that need to be done the website for security purposes, to become ADA compliant, and for the site to be mobile friendly. Berg stated that she liked the user friendliness and navigation of the Revise websites. There were some extras that were added onto a couple proposals that Berg isn't sure are needed and she has requested a new proposal from Revise for a cost without those extras, but for the time being she is giving an estimate based on what she had been told from her Revise contact.
