**APPROVE SICOG RESOLUTION:** Moved by Shelley and seconded by Twombly to approve **Resolution #2022-32** – This Is a Resolution to Participate in the Planning and Development Programs of the Southern Iowa Council of Governments. Whereas, the Economic Development Administration was assigned to administer the provisions of the Public Works and Economic Development Act of 1965; and Whereas the Southern Iowa Council of Governments has been designated by the Economic Development Administration as an Economic Development District and Whereas the State of Iowa and the U.S. Department of Housing and Urban Development has designated the Southern Iowa Council of Governments as the area wide planning organization, and Whereas Adair County is a past member of the Southern Iowa Council of Governments and has participated in formulation of area wide plans and programs. Be It Therefore Resolved by the Adair County Board of Supervisors that Adair County desires to participate in the fiscal year 2023 planning and economic development programs of the Southern Iowa Council of Governments in Iowa Planning Area XIV, consisting of Adair, Adams, Clarke, Decatur, Madison, Ringgold, Taylor, and Union Counties. Be It Further Resolved by the Adair County Board of Supervisors that Adair County provides \$3,916.89 for the operation of the Southern Iowa Council of Governments' planning and development programs. **PUBLIC HEARING:** Moved by Shelley and seconded by Twombly to open the Public Hearing for road classification change at 9:30 a.m. No comment was received by the Auditor, Engineer, Supervisors, or Public. Moved by Twombly and seconded by Walker to close the public hearing at 9:31 a.m.

RESOLUTION APPROVING CLASSIFICATION CHANGE: Moved by Shelley and seconded by Walker to approve Resolution #2022-33 – Resolution for Reduced Level of Maintenance to Area Service "C" Road. Whereas, Adair County desires to classify certain roads on the area service system in the County to provide for minimal level of maintenance and access by means of a gate or barrier; and Whereas, the County, after consultation with the County Engineer, has the authority to specify certain roads within the County as Area Service "C" roads pursuant to Iowa Code Section 309.57; and Whereas, the only person who will have access rights to the roads shall be: 1. The owner, lessee, or person in lawful possession of any adjoining land, 2. The agent or employee of the owner, lessee or person in lawful possession of any adjoining land, 3. Any peace officer, 4. Any magistrate, 5. Any public employee whose duty it is to supervise the use or perform maintenance of the road, 6. Any agent or employee of any utility located upon the road. Whereas, the minimal level of maintenance will be as follows: 1. Blading. Blading or dragging will not be performed on a regular basis. 2. Snow and Ice Removal. Snow and ice will not be removed, nor will the road surface be sanded or salted on a regular basis. 3. Signing. Except for load limit posting for bridges, signing shall not be continued or provided. All area service level C roads shall be identified with a sign at all points of access to warn the public of the lower level of maintenance. 4. Weeds, Brush and Trees. Mowing or spraying weeds, cutting brush and tree removal will not be performed on a regular basis. Adequate sight distances will not be maintained. 5. Structures. Bridges and culverts may not be maintained to carry legal loads. Upon failure or loss, the replacement structure will be appropriate for the traffic thereon. 6. Road Surfacing. There will be no surfacing materials applied to Area Service System C Roads on a regular basis. 7. Shoulders. Shoulders will not be maintained on a regular basis. 8. Crown. A crown will not be maintained on a regular basis. 9. Repairs. There will be no road repair on a regular basis. 10. Uniform Width. Uniform width for the traveled portion of the road will not be maintained. 11. Inspections. Regular inspections will not be conducted. Therefore, be it resolved by the board of supervisors of Adair County that this County does hereby establish the road descripted as an Area Service "C" road, with restricted access and a minimal level of maintenance. That portion of "305th lane" established April 6th, 1896 (see road record book 4, page 86), commencing at the north guarter corner of the southwest guarter of section 15, township 74 north, range 33 west of the 5th P. M. Adair County, Iowa, thence 660 feet east along the north line of the southwest guarter of said section 15, at a uniform width of 50 feet. That portion of "305th Lane", established June 4th, 1900 (see road record book 4, page 298), commencing at a point located 130 feet west of east guarter corner of section 16, township 74 north, range 33 west of the 5th p.m., Adair County, Iowa, thence east along the north line of the northeast guarter of the southeast guarter of said section 16, a distance of 130 feet, to a point known as the east guarter corner of said section 16, thence east along the north line of the northwest guarter of the southwest guarter of section 15, township 74 north, range 33 west of the 5th p.m., a distance of 1320 feet, at a uniform width of 40 feet.
