FY20 & FY21 ZION AUDIT: Supervisor Wedemeyer presented the FY20 and FY21 Zion Audit. Moved by Hoadley and seconded by Shelley to acknowledge receipt of the Zion audit. Approved.

FY2022 TRANSFER RESOLUTION: Moved by Shelley and seconded by Walker to approve **Resolution #2022-48** – Transfers FY2022. Be it Resolved by the Adair County Board of Supervisors to direct the Adair County Auditor to transfer \$84,662.50 from the NW Wind Farm UR Debt Service Fund (0032) to the General Fund (0001) for TIF Project Expenditures incurred and certified as debt in November 2020. Roll Call Vote: Wedemeyer, aye; Shelley, aye; Hoadley, aye; Walker, aye; and Twombly, absent. Approved.

CHILD ABUSE PREVENTION GRANT DRAW DOWN: Moved by Hoadley and seconded by Walker for Auditor Berg, as contract administrator, to sign the Child Abuse Prevention Grant Draw Down. Approved.

LANDFILL RECYCLING CHANGES: Supervisor Wedemeyer stated that two weeks ago the Landfill Board voted to no longer have plastic in the community recycling bins. All plastic bins will be relabeled for mixed paper. The landfill recycling bins will still take plastics. Wedemeyer explained that the Landfill can't handle someone sorting through the plastics as most of it tends to be trash and the landfill is paying money to just get rid of it. Wedemeyer also stated that a lot of education would be needed to get the word out and that it will be put in all the newspapers.

CONSERVATION: Seasonal Naturalist Introduction – Sabrina Becker introduced herself as the AmeriCorps Seasonal Naturalist for Adair County. Becker described the camps she has been setting up for kids aged preschool through 12th grade. She is also planning on attending the City Park Markets a few days during the summer and working with Cass County as they have yet to find a seasonal naturalist. Conservation Director Johnson explained that Becker works on Conservation education 4 of the 5 days she works during the week and the fifth day is spent as a floating day to learn and amp up her resume. Johnson stated that this program is possible due to the Empowering Adair County Grant that Conservation receives. Longevity Increase – Moved by Shelley and seconded by Hoadley to approve the \$0.15/hour longevity for Chris Kerber for completion of 15 years at the County effective May 21, 2022. Approved. Camping & Maintenance Update – Johnson stated that it was a slow spring camping season but things are getting busier with \$4,000 in camping revenue last week alone. Lake Orient has been full for over a week minus some of the tent camping spaces. As of today, conservation has brought in \$44,268 in camping revenue with another month to go compared to last year's total of \$44,573. They have been re-rocking camping pads at Orient, will be working on more Kiosks and parking barricades during the summer, and have planted 600 trees at Hoskins Wildlife Area and 500 trees in other parks. Johnson and the Board discussed the new bath house at Mormon Trail. Johnson stated that they are waiting on a perc test before determining a location and that delivery of the bath house should be late fall. Johnson expects that the project should be completed before the end of year before it freezes. Johnson also stated that they have had a lot of compliments on the shower house and Bridgewater beach.
