ENGINEER: Calvary Cemetery Improvements - Engineer Kaufman explained that we were planning on resurfacing the road to Calvary Cemetery with TIF funding this fiscal year. However, the City of Stuart now has a road project going on and has guoted the County cost of doing the road up to the Calvary Cemetery for \$78,827.75. The City would mill out the areas that are broken and then patch and do an overlay. Having the City do the project would save the County significantly. Moved by Twombly and seconded by Hoadley to move forward with the City of Stuart of doing the Calvary Cemetery Road project. Approved. Maintenance & Activities Report - Engineer Kauffman gave an update to the Board on the following projects: final Cott Systems project amount for the road plat book will be \$770, Gus Construction is done on Pinewood North of Orient, bridge on Brown Avenue, G61, pulling up edges on York and 130th, was awarded \$10,000 to put towards a UTV purchase, and contacted by a citizen regarding the Navigator Pipeline and how phase 2 could affect the County.
