IMWCA PAYROLL WORKSHEET: Moved by Baier and seconded by Wedemeyer to approve the IMWCA payroll worksheet for the County's worker's compensation renewal. Approved.

MANURE MANAGEMENT PLAN UPDATES: Moved by Twombly and seconded by Wedemeyer to acknowledge receipt of the manure management plan updates for Steele Land and Livestock and Todd Van Eaton. Approved.

BROADBAND INTERVENTION ZONE LETTER TO OCIO: Supervisor Walker stated that they are working on getting an approval for a grant to improve Broadband in the Southeast part of the County. Supervisor Hoadley stated that they are asking for letters of support and have talked with Crossroads, School districts, Sheriff Vandewater, and the Hospital. Moved by Hoadley and seconded by Twombly to proceed with the Broadband process and for the Chair to sign the Broadband Intervention Zone Letter to the Office of the Chief Information Officer that includes a map of the targeted area. Approved. Nick Kauffman entered at 9:06 a.m.

SET PUBLIC HEARING – FY24 BUDGET: Moved by Hoadley and seconded by Baier to set the public hearing for the FY24 budget for April 12, 2023 at 9:15 a.m. Approved.

ENGINEER: Award Resolution – Moved by Twombly and seconded by Baier to approve Resolution #2023-19 – Award of Bid for Project L-LRCBN25GR—73-01 260th St.: 950' East of York Ave. – This project involves replacing an exiting metal pipe culvert with a reinforced concrete box culvert along Adair County 260th St. The project will also include the placement of revetment, granular surfacing, and seeding. Be It Resolved, by the Adair County Board of Supervisors, as follows: Section 1: That bid for L-LRCBN25GR—73-01 be awarded to the low bidder, GUS CONSTRUCTION CO., INC., CASEY, IA for the total cost of \$176,041.40. Section 2: That the chair be authorized to sign the contract documents on behalf of the board. Section 3: That this resolution shall take effect immediately. Moved by Twombly and seconded by Hoadley to approve the right of way contracts with Gene Welsch for \$378.96 and \$468.43 for the N72 culvert project. Approved. Maintenance & Activities Report – Engineer Kauffman gave an update to the Board on the following projects: Cohron is working on Section 33 Washington, Murphy is working on rip rap, crack filling will start tomorrow on Stuart Road, hauling rock and blading roads, South of Fontanelle project box culvert has been pushed back, Hungry Canyon awarded 80% of funds for box culvert extensions on Friday. John Thomas entered at 9:15 a.m. Colleen Oxley entered at 9:17 a.m.

HUNGRY CANYONS: John Thomas, Hungry Canyons, introduced himself and discussed the Hungry Canyons Alliance Program with the Board. The program consists of 19 counties and has been funded through Federal funds, State funds, and \$5,000 in dues from each County annually. Adair County has received \$853,000 from Hungry Canyons for cost share projects. Hungry Canyons also provides an additional 10% match for EWP projects, reducing the burden of the County to a 15% match. Thomas discussed the different types of projects that Hungry Canyons helps pay for.
