AGLAND & FAMILY FARM DISALLOWANCES: Moved by Baier and seconded by Hoadley to approve the Family Farm and Agland disallowances and for the chair to send a letter. Approved.

GRANT DRAWN DOWN: Moved by Twombly and seconded by Baier for Auditor Berg, as contract administrator to sign the Child Abuse Prevention Grant Draw Down. Approved.

HEALTH, DENTAL, & VISION INSURANCE RENEWAL: Moved by Twombly and seconded by Hoadley to sign the FY25 Health, Dental, & Vision insurance renewal documents. Approved.

SHERIFF: Sheriff Jeff Vandewater stated that a jailer/dispatcher was going to be retiring April 8th and he would like to start the hiring process now for a replacement. Moved by Baier and seconded by Hoadley to allow Sheriff Vandewater to start the hiring process to replace the dispatcher/jailer. Approved. Vandewater and the Board discussed the timeframe and training of new jailers and dispatchers and how the lack of an officer in the City of Adair will affect the County.

ENGINEER: Bridge Repair Proposal – Moved by Twombly and seconded by Hoadley to approve the repair proposal of \$76,300 for the N6 Grand River Bridge. Approved. Engineer Kauffman stated that this would be paid from LOST funds. **E911 Budget Discussion** – Kauffman stated that he had been back and forth with South Central Iowa E911 for a few months about replacing the street signs in the County. They have \$100,000 available to the County to replace rural signs. Kauffman estimates that it would take around \$105,000 just to cover the cost of the 2,660 signs and another \$100,000 for posts and other supplies. Thankfully the \$100,000 from South Central Iowa E911 will pay for the materials directly and is not a reimbursement and that there is not time frame that the signs have to be replaced by. Kauffman and the Board agreed that we can just replace the signs as we can and adjustments may need to be made to the budget. **Maintenance & Activity Report** – Engineer Kauffman gave an update to the Board on the following projects: stockpiling rock, putting reclaimed rock on 227th, will have two bid lettings on Monday, and cutting brush.
